INTERNATIONAL E-CONFERENCE

The International E-Conference on the theme of "Interplay of Law and Society." was organized by SVKM's NMIMS School of Law, Indore on January 27, 2024; with the objective of examining how society and law are evolving through the perspectives of socioeconomic, political, and legal issues. The main aim of this conference was to bring together leading academicians, researchers, technocrats, practitioners, and students to exchange and share their experiences and research outputs on all aspects of law and society. The conference delved into a wide range of sub-themes, including global political crises, public policy, gender and caste diversity, geopolitics, socio-economic justice, legal technology, environmental sustainability, corporate governance, and more.

More than 125 abstracts covering a wide range of multidisciplinary issues were submitted by participants from various universities, like NLU Ranchi, GNLU Gandhinagar, CNLU, O.P. Jindal, and various others. The conference maintained a high-quality peer-review process for all the manuscripts submitted, starting with a primary evaluation of the abstract. Due to multidisciplinary sub-themes, presenters were able to submit papers on various topics. in response to the event, which received a great deal of enthusiasm. More than 75 papers were chosen for presentation at the conference following an extensive evaluation procedure. These studies covered a wide range of topics and provided novel insights into how the law and societal issues interact. Participants further discussed the challenges and opportunities facing legal systems in the modern world, particularly focusing on themes such as societal needs, values, and aspirations.



An impressive inauguration ceremony started the conference and set a thoughtful and positive tone for the day. A traditional Saraswati Vandana was performed to invoke the goddess of knowledge's blessings before the event got underway. In his introductory remarks, Dr. Ashutosh Hajela, Associate Dean of SVKM's NMIMS School of Law, greeted the guests and underlined the value of interdisciplinary legal debate. In the provocative lecture delivered by, Dr. Anshuman Jaswal, the Director of SVKM's NMIMS Indore Campus, emphasised the necessity for legal scholars and students to bridge the gap between legal theory and societal demands and the critical role that law plays in tackling socio-economic imbalances.




Two distinguished chief guests, Prof. (Dr.) Poonam Pradhan Saxena, a former vice-chancellor of NLU Jodhpur, and Prof. (Dr.) Shilpa Khatri Babbar of the University of Iceland added more value to the conference. The two dignitaries gave powerful addresses that discussed the complex ways that society forces influence law and how law is shaped by them. In their speeches, they emphasised the importance of this interaction and the necessity for legal systems to change and advance in step with shifting social dynamics. Dr. Babbar provided historical examples, reflecting on how societies that adapt their legal systems to current socio-political realities have flourished. She elaborated on how universal legal principles often require modification to reflect the values and traditions of different societies, advocating for a more inclusive and culturally sensitive legal system. The Guest of Honour was Dr. Durgambini Patel, Dean of SVKM's NMIMS Kirit P. Mehta School of Law, who also gave closing remarks at the inaugural session. She commended the conference for promoting important scholarly conversations that are relevant to contemporary issues.

After the enlightening keynote session, the conference proceeded with 12 parallel technical sessions. Expert chairpersons and co-chairpersons from a variety of esteemed institutions attended each session. This well-selected team of judges guaranteed the calibre of the talks and presentations, encouraging fruitful exchanges amongst contestants. Expert Chairpersons with a total of twelve Co-Chairpersons provided their instrumental support in the competition of the technical sessions. The technical sessions served as a forum for rich discussions and critiques on various legal issues ranging from human rights, environmental law, gender justice, criminal law, and many more.

The conference concluded with a valedictory ceremony, three eminent keynote speakers shared their knowledge on the changing dynamic between law and society: Dr. Daniel Stein, Assistant Professor at O.P. Jindal Global University; Dr. Christine Richardson, Associate Professor at Jagannath University in Dhaka, Bangladesh; and Dr. Rachna Chaudhary, Associate Professor at Dr. B.R. Ambedkar University in Delhi. Their insightful comments gave the thought-provoking event an appropriate conclusion. Their contributions enriched the discussions and broadened the understanding of the interplay between law and society in different contexts. Scholars from various other countries participated and contributed to the discussions, fostering a global exchange of ideas.

During the valedictory session of the conference, the winners of the Best Paper Awards were revealed in honour of their academic achievements. To honour the presenters' accomplishments, prizes were given to the top three papers, which showed outstanding research quality and uniqueness.

2ND NATIONAL MOOT COURT COMPETITION

The Moot Court and Trial Advocacy Society successfully organised the 2nd National Moot Court Competition in April 2024. The competition centred around a case that explored Marriage and Adoption Rights of Transgender Persons in India.

The competition began with a total of 15 teams from various institutions across the country, including Symbiosis Law School Pune, UPES Dehradun, and Sastra University, Tamil Nadu. The plethora in the pool of participants showcased their exceptional advocacy skills in the preliminary rounds of the competition, held online on the 6th of April, 2024.

The Preliminary rounds commenced with an orientation session, followed by online memorial submissions, the preliminary rounds were concluded by a presentation of oral arguments featuring echo of reasoned and intellectually stimulating arguments and counter-arguments from both sides. Following the preliminary rounds, 8 teams qualified for the subsequent rounds which were held on campus from 12th to 14th April 2024. The inaugural ceremony was followed by the Draw of Lots and the Researcher's Test.

The second day commenced with the Quarter-Final rounds, where the teams demonstrated exemplary skills during the oral arguments. The panel of judges included distinguished personalities such as Mr. Akshay Pathak, Principal Associate at Cyril Amarchand Mangaldas, Noida, Mr. Ashutosh Chugh, Associate at Satram Das B & Co., Ms. Bhavinee Mishra, Legal Consultant, Directorate of Enforcement, Kolkata, among others.



The Quarter-Finals were followed by the Semi-Finals, where the 4 winning teams from the previous round competed against each other for a spot in the Final Round. The panel of judges for the Semi-Finals included legal luminaries such as Mr. Ayush Jain, Founding Partner at Advik Law Partners, Mr. Biplab Lenin, Partner at Cyril Amarchand Mangaldas, Mr. Deepak Awasthi, Advocate at Madhya Pradesh High Court (Jabalpur Bench), and Mr. Priyvrat Singh, Partner at Advik Law Partners.

On the final day, the Final Round took place between the participants from Government New Law College, Indore, and Symbiosis Law School, Pune. The participants engaged in an intensive legal battle, judged by the esteemed sitting Judges of the Madhya Pradesh High Court, Hon'ble Mr. Justice Anil Verma and Hon'ble Mr. Justice Pranay Verma.

All the participants were subsequently applauded for their exemplary advocacy skills. Government New Law College, Indore, was adjudged the winner of the competition, with Symbiosis Law School, Pune, and ILS Law College, Pune, securing the 1st and 2nd Runner-Up positions, respectively. The Best Memorial Award was presented to Symbiosis Law School, Pune, while Brindalakshmi from Sastra University, Tamil Nadu, was named as Best Advocate. The Best Researcher Award was presented to Anshika Tripathy from Government New Law College, Indore. The competition was a resounding success owing to the unwavering dedication exhibited by the toil of Committee Members, Faculties, and the Participants.







1ST NATIONAL MEDIATION COMPETITION

The First National Mediation Competition, organized by SAMADHAN—The Alternative Dispute Resolution Cell—in collaboration with Associate Partners Nishith Desai Associates, Singhania and Partners, and Economic Laws Practice, along with Knowledge Partners YCM, Lawctopus, MIAMC, and MediateGuru, and Media Partners Lawctopus and Legal Tech Partners Manupatra, was a comprehensive event that explored key aspects of mediation.

The competition commenced on the of April, 2024, with Inaugural Ceremony, Participants from institutions including RGNUL DNLU Patiala. Jabalpur, Jindal Global Law School Haryana, Symbiosis Nagpur, and various others showcased their negotiation and compromise skills, highlighting that the legal profession extends beyond litigation to finding mutually beneficial solutions.



The competition consisted of four rounds: a preliminary round and quarter-final round of 45 minutes each, followed by semi-finals and finals of 60 minutes each. The judging panel included esteemed figures such as Ms. Rukmani Menon (Partner at Menon & Menon Associates and Director at CAMP, Bangalore), Mr. Vikas Goyal (Senior Partner, Singhania & Partners LLP), Ms. Pushp Gupta (International Mediator & Legal Advisor to the Indian Medical Association), and other distinguished legal experts.

The judges' panel comprised seasoned legal experts from various fields. Mr. Jeevan Ballav Panda (Khaitan & Co.) brought 16 years of arbitration experience, while Mr. Nachiketa Goyal (Kochhar & Co.) contributed his expertise in corporate litigation. Ms. Ritu Bhalla (Luthra & Luthra) and Ms. Surabhi Khattar (Cyril Amarchand Mangaldas) offered decades of experience in dispute resolution and corporate matters.







Esteemed judges, including Ms. Rukmani Menon, Director at CAMP; Mr. Vikas Goel, Senior Partner at Singhania & Partners LLP; Ms. Pushp Gupta, International Mediator; Mr. Jeevan Ballav Panda, Partner at Khaitan & Co.; and Ms. Ritu Bhalla, Partner at Luthra & Luthra, contributed to the event, adding depth and expertise to the proceedings.

At the end of the competition, the Best Client-Counsel Pair award went to OP Jindal Global University, with Maharashtra National Law University, Nagpur, securing the Runner-Up position in the same category. The title of Best Mediator was awarded to Jagran Lake City University, while Symbiosis Law School, Nagpur, finished as the Runner-Up in the Mediator category.

The judges praised OP Jindal Global University's team for their strong advocacy and case preparation, earning them first place in the Client-Counsel category. Jagran Lake City University's mediator was recognized for exceptional conflict resolution skills, winning the Mediation category. MNLU Nagpur's team was commended for their legal acumen, securing the Runner-Up position in the Client-Counsel category, while Symbiosis Nagpur's mediator was recognized for effective communication and negotiation, taking the Runner-Up position in Mediation.

1ST NATIONAL YOUTH PARLIAMENT

Samvaad-The Debating Society's 1st National Youth Parliament, Samvaadik, was a huge success, attracting over 70 participants from 35 prestigious institutions. The three-day event, held from April 12-14, 2024, featured two committees: The Lok Sabha and The All India Political Party Meet (AIPPM). Participants stepped into the shoes of various prominent political leaders as they braced through the competition.

The competition started with the Executive Board Members, including Mr. Aditya Bhatt and Mr. Aman Khan (Lok Sabha) and Mr. Pahal Teware and Ms. Jahnvi Jain (AIPPM), addressing the participants and specifying the rules of the events, later focusing on their specific agendas for the competition.







LOK SABHA

The Lok Sabha focused on addressing Relocation with special emphasis on Rehabilitation Policy for Kashmiri Pandits. The session began with opening statements from delegates, including Mr. Narendra Modi and Mr. Rahul Gandhi, followed by debates and discussions supported by statistical evidence. The committee unanimously passed a motion to discuss economic and social infrastructure in Jammu & Kashmir after the abrogation of Article 370. The closing arguments were given by Smt. Sonia Gandhi.

AIPPM & PRESS RELEASE

The AIPPM committee critically assessed the policies during the NDA government's term. Delegates passionately presented arguments, with positive arguments highlighting improvements in defence and security measures, while critics argued that the NDA's promises lacked clarity. Prime Minister Narendra Modi addressed the session, highlighting his government's achievements.

Later the Press Release of the Committee Meetings was held wherein the reporters covered the highlights of the session, where leaders of national parties faced heated questions from the press.

During the valedictory ceremony, participants were awarded for their exceptional skills. Shri Mithun Reddy was adjudged the Best Parliamentarian, and Kunwar Danish Ali emerged as the High Commendation in the Lok Sabha committee. Shri Manoj Kumar Jha was declared the Best Delegate, and Shri Bhagwat Mann as the High Commendation in the AIPPM committee. The event's success was attributed to the dedication of committee members, faculties, and participants.



1ST NATIONAL LEGAL AID POLICY DRAFTING COMPETITION

The 1st National Legal Aid Policy Drafting Competition, themed "Equal Justice, Accessible Paths: Legal Aid Policy-Making Competition for Divyaangjan," was a landmark event organised by SAMATVA—The Legal Aid Society of NMIMS Indore. Held on April 14, 2024, the competition aimed to address the unique challenges faced by the differently-abled community and sought innovative policy solutions to ensure equal access to justice. The event was a significant step towards fostering inclusivity and accessibility within India's legal framework.

Participants were required to submit their policy drafts, ensuring the drafts were comprehensive, practical, and innovative. The submissions underwent a rigorous review process by an external panel of anonymous judges to maintain impartiality and fairness. Out of the 24 submissions received, five were shortlisted for the presentation round based on originality, feasibility, and potential impact.



The presentation round was the highlight of the competition, with the shortlisted teams presenting their policy drafts in detail. Each team was allotted 20 minutes for their presentation, which included a 15-minute policy deliberation followed by a 5-minute Q&A session with the judges. The presentations were evaluated on various criteria, including clarity, depth of analysis, and practicality of the proposed solutions.

The judging panel comprised esteemed professionals and academicians who provided valuable insights and feedback. The panel included: Dr. Victor John Cordeiro: An expert in disability rights and advocacy, Dr. Cordeiro emphasised the need for societal sensitization toward the issues faced by the people with disabilities, Shri Rajesh Dandotiya: A renowned legal scholar, Shri Dandotiya highlighted the importance of changing societal perspectives toward the specially-abled and called for more inclusive policies. The 1st runner-up was awarded to Team, represented by Ms. Lavanya Bhatt and Mr. Subramanyam H. from Delhi Metropolitan Education College, whose policy draft was noted for its thorough analysis and practical approach.

IN CONVERSATION WITH LEGAL PIONEERS

MEET OUR ESTEEMED GUEST

Advocate Harsh Pratap, founder of HP Law Advocates, a leading Indian law firm specialising in Maritime Law, with a strong record of accomplishment of working with clients from India and abroad. Advocate Harsh Pratap has been practising law since 2001 and has completed LLM in Maritime Law from the Institute of Maritime Law, University of Southampton in 2005.



During the academic interview with Pragyan, Advocate Harsh Pratap made familiarizations around the technicalities involved in pursuing Maritime Law as a legal career, he was generous enough to guide us through the following major questions.

Interviewer: Could you discuss what Maritime Law is and how it differs from Admiralty Law?

Advocate Harsh Pratap detailed that, Maritime law is a wider concept in itself concerning a ship, the water, the sea, these are mainly all-encompassing maritime law. He further explained that Maritime law is a legal framework which covers under its ambit activities on the sea and various aspects of shipping, contracts, cross-border transactions and disputes. Admiralty Law is a subset dealing specifically with ships and waters, while Maritime Law covers broader civil matters, including contracts, piracy laws, and insurance. He noted that India has admiralty laws dating back to 1861 from the British colonial period, but the scope of Maritime Law is much wider and more internationally oriented. Well India, does not have many laws concerning maritime but there is a wide branch such as we have the marine insurance act, Indian ports act 1908 and more.

Interviewer: What is the scope of Maritime Law in India, given the relatively limited number of laws under the ambit, also is there a positive or a negative improvement in comparison to countries like United Kingdom and United States of America?

In his opinion, the scope in India is definitely big but comparatively, UK is a much larger country because UK sees cases from all over the world. He further exemplifies that if you have a case between a Spanish and a German, it is very much possible that the contract might be governed by the states and the states obviously need to go to a negotiation level. In that sense, unfortunately, but India is not a maritime hub when it comes to the issues. It is a practice that is taking up. At this stage, he added that we are not in a position to compete ourselves or compare ourselves with the UK system. Certainly, UK is far more robust and far more developed, and we should still look for guidance to the UK cases because they are the ones that are cited by most other jurisdictions. Even governments in Singapore, Hong Kong, etc. would be citing UK based law cases.

Additionally, he exclaimed, that America has a slightly different maritime system to an extent, but it is not vastly different in all aspects. India is becoming more of a global hub in terms of, exporting goods, it is observing a lot of foreign companies also one of the beneficial points could be the extremely large port lines.

Interviewer: How would you describe your journey as a maritime lawyer? How much time is needed to be a well-established maritime lawyer?

His journey as a maritime lawyer could be precisely described as slow and a steady process. Maritime law was always a calling for him as being influenced by his father's career as a sailor. Early on in his legal career he gained valuable experience by interning and working under a renowned shipping lawyer for a tenure of 11 years. After gaining practical experience he pursued LLM in Maritime Law from one of the top universities in the world, University of Southampton in 2005. According to him, it is advisable to consider gaining practical experience before starting out own independent practice as a maritime lawyer, taking time to develop your skills and learning through the legal process is essential as maritime legal market is highly competitive. Also, he guided that when a student consider master's for maritime law, they should do it from a common law country like the UK or Singapore. The reason being, India follows a lot of British laws and is a common law country itself. Not only maritime, but even in matters concerning contracts.

He further added that if you would want to continue your journey as a Maritime Law aspirant in India itself it could be considered but it would be a slow and steady process.


Furthermore, if one wants to become a well-established maritime lawyer, they would need at least 5 years of practice under a reputable lawyer to further start practice independently.

Interviewer: What are some major skills required to excel in the field?

He addressed this query by stating that Patience is one of the most important skills. Maritime law is a specialised field which might be in some cases be unfamiliar to the judges as well, which makes it imperative to be prepared and correct any misconceptions and pursue a deep understanding of Maritime Law principles. Therefore, a maritime lawyer according to him to excel in his field would require patience as one of his/her attributes.

Furthermore, he claimed that it is also a profession where long hours would be required.

One of the reasons for that as stated by him were because it is international in its operation, and one might be having an international client therefore sincere punctuality would be needed whenever the client might need the lawyer. The third skill which he exclaims was reading. There will be a lot of reading in the field. The vastness of this field according to him requires rigorous research and reading so conclusively it would be another imperative skill to pursue.


BOOK REVIEW OF ROBIN SHARMA'S WHO WILL CRY WHEN YOU DIE?

Who Will Cry When You Die? is another masterpiece by Robin Sharma, a litigator-turned-author who has also penned titles such as *The Monk Who Sold His Ferrari*, which also happens to be amongst the best-sellers in the literary marketplaces. His writings include meticulous and vivid expressions of subjects pertaining to self-help and didactic fiction.

This book presents simple yet highly effective ways to change one's perspective on life and teaches one how to become the best version of oneself. The author's central argument is that humankind aspires and is in continuous hustle to leave a legacy which is cherished upon their demise and continues to hold a significant impact even in their absence. However, the same raises some serious and thought-provoking questions, namely: will we anyway matter after our death? will our anecdotes, knowledge, and values not be divided across perceptions? Will people actually feel any sorrow at our funeral? These are some questions Robin Sharma explores throughout the book.

The book is divided into 101 chapters, each offering different methods to enrich our lives with peace, happiness, balance, success, abundance, and fulfilment. The author shares his personal experiences and life lessons. In one chapter, he refers to the first thirty minutes after waking up as 'The Platinum 30,' emphasizing that this point of time in one's life is quite crucial for focusing on oneself. In another chapter, he encourages readers to become more proactive and view themselves as the CEO of their own destiny—the CEO of their life.



I firmly believe that through the practice of principles laid-down in the book, we can become the captains of our own ships, rather than mere passengers. Sharma argues you don't need to wait until your deathbed to realize the meaning of life. He states simply, "The purpose of life is a life for a purpose." As you progress through the book, you'll discover ways to live meaningfully, set high goals, and achieve them, all of which contribute to a positive attitude toward yourself.

No self-help book is complete without motivational quotes, and Robin Sharma has included plenty of those from much eminent personalities such as Norman Cousins, Thoreau, Mother Teresa, Sophocles, and others. My personal favourite is by Norman Cousins: "The tragedy of life is not death, but what we let die inside of us while we are alive."

Sharma's use of effective, straightforward language makes the book easy to understand. He emphasizes that while physical life is temporary, the legacy we leave can serve as an example for future generations. Our values and achievements will be remembered, and render us to immortality. I believe that embracing such a mindset can help in personal growth and reaching greater heights. The book concludes in a way that it does not impose its opinions on the readers and thereby does not strictly fall as didactic fiction, as the author asks, "The only question is, will you choose to do so?"



BOOK REVIEW ON 'FRACTURED TALES INVISIBLES IN INDIAN DEMOCRACY'

Fractured Tales documents the narratives of the voiceless and invisible Dalit castes that have been left out in the 60 years of state-led Indian democracy. Exploring the deepening of democracy among the Dalits of Uttar Pradesh, it argues that the process of democratization of these communities overrepresents some groups, such as the Chamars and Pasis, while neglecting others like the Musahar, Bansphor, and Sapera communities. In this book, the author examines 'how' and 'why' the process of dem-





In this book, the author examines 'how' and 'why' the process of democracy reached a small, select group amongst the Dalits in UP, like the Chamar and Pasi castes, while several other castes like Musahar, Bansphor, Sapera, Nat, and so on, did not even get a small glimpse of democratic empowerment. The author creatively captures their growing sense of exclusion from democracy and representation, and their cry for inclusion, which is yet to transform into an assertion in the domains of the nation, state, democracy, and society.

The author has prepared ground for the narrative of investigating the workings of democracy in North India, especially in the context of Dalit empowerment in UP, and has tried to discuss invisibility and voicelessness in the context of democracy. The story takes place in Uttar Pradesh, India. The author started working on Dalit issues in Uttar Pradesh in the 1990s, around twenty to twenty-five years ago, at the time when the Bahujan Samaj Party (BSP) emerged on the political scene and was gradually gaining ground in UP. There are various instances mentioned in the book that describe the setting of the story.

The author talks about the emergence of the Bahujan Samaj Party, documenting BSP politics and being filled with enthusiasm and expectations for a bright future for Dalits. The emergence of BSP was a harbinger of good tidings—the hopes that the party had instilled in the hearts of long-suffering Dalits did come true to some extent, as they had begun to occupy center stage in the political scenario of both UP and the country and could aspire to a better life due to their political empowerment.

The main conflict of the story is 'how' and 'why' a few dalit castes have succeeded in becoming politically empowered and visible while the rest of the dalit castes are lagging behind in the state-led democracy and did not even get a briefest glimpse of democratic empowerment. In this celebration of democracy it is often overlooked that the dalits comprise a large number of castes and communities and of these only a few castes that make up a small section of the total dalit population have acquired visibility, while a huge cluster of dalit communities are still very far from the door of democracy. The state led democracy has not only created empowerment but also triggered its opposite, disempowerment.

This book focuses on dalit castes that are voiceless, invisible and have been left out in the almost 60 year discourse of state-led Indian democracy. It presents a catalogue of the dalits, that is of the most marginalized among them who were left out from the discourse of democracy even during the chief ministership of leader of the BSP Mayawati, who claims to work for the uplift of the oppressed and the marginalized (dabe-kuchle log) through democratic power.



It documents that on one hand, democracy that includes the assertive castes on the margins of politics and governance, while on the other hand excluding many non-assertive and small castes existing on the margins among the margin, as a byproduct of its functional character.

LEGAL HORIZONS

Legal insights around the globe

- The Paris Agreement, an international treaty on climate change, has set its objective to keep the global temperature below 2 degrees Celsius, most preferably at 1.5 degrees Celsius. This must be followed by a decline in global emissions by 45% by 2030 and reaching net zero by 2050. To leverage its commitment toward this objective, India is taking active steps in introducing policies such as the "National Action Plan for Climate Change" (NAPCC), the "State Action Plan for Climate Change" (SAPCC), and "India's Long-Term Low Carbon Development Strategy" (LT-LEDS). Furthermore, India is leading a mass movement towards environmental protection in respect to national determination contributions set by the Paris Agreement by including LiFE (Lifestyle for Environment) as a mission to incorporate into protecting and preserving the environment. India is the first country to adopt such an initiative, reflecting its enthusiasm and commitment to the objective.
- On the occasion of the 75th anniversary of the establishment of the Hon'ble Supreme Court, President Droupadi Murmu unveiled a new insignia of the Supreme Court. The notable event was graced by presence of Hon'ble Minister of Law & Justice, Mr. Arjun Ram Meghwal, Hon'ble Chief Justice of India DY Chandrachud, and other dignitaries. The new flag featured the Sanskrit shloka, "Yato Dharmastato Jayah," which means "where there is Dharma, there is victory," portraying the objective of the judiciary to embark on a new era of modernized and simplified ways to provide justice.
- On August 2, 2024, Brazil approved a bill that sets up the legal framework for low-carbon hydrogen emissions, creating the National Low-Carbon Hydrogen Policy. This policy will further be introduced as part of the country's National Energy Policy. The law introduces the Brazilian Hydrogen Certificate System; the certificate will inform the intensity of emissions related to the hydrogen production chain, making it viable for officials to keep track of hydrogen production. The law allows the country to eliminate actions that allow unnecessary emissions and wastage of energy, which could further impact the globe. Such initiatives could be a potential inspiration for other countries to take action towards climate change and environmental concerns.

- Adopted on May 17, 2024, the world's first legally binding global treaty on artificial intelligence, "FRAMEWORK CONVENTION ON ARTIFICIAL INTELLIGENCE AND HUMAN RIGHTS, DEMOCRACY, AND RULE OF LAW," marks a historic milestone in global AI regulations. Initiated by the Council of Europe, it will set new international standards to align artificial intelligence systems with democratic values, human rights, and the rule of law. It also has the potential to establish a legal framework that will regulate and align every initial stage of the AI system. The convention also appends the world's first extensive AI regulation, the EU AI Act. The treaty introduces itself in alignment with the EU AI Act and assimilates elements such as fostering safe innovation and focusing on a human-centric AI system.
- On March 23, 2024, Hong Kong announced new security laws which have faced widespread international criticism for their repressive nature. The law introduces itself under Article 23, which allows for "closed-door trials" and permits police officials to detain suspects for up to 16 days without any charge. The law also allows for banning organizations and companies that are suspected of being allies with foreign forces. The jurisdiction of the article broadens itself with the "Beijing-imposed National Security Law," which involves criminalizing secession, subversion, terrorism, and collusion with foreign forces.
- The 23rd Law Commission has been established by the government of India, which will commence its operation from September 1, 2024, to August 31, 2027, for a span of three years. Its aim is to investigate and suggest potential reforms and actions needed for the smooth and orderly functioning of the judicial system of the country. The commission will be headed and guided by a full-time chairperson, four full-time members, the Secretaries of the Legal Affairs and Legislative Departments as ex-officio members, and up to five part-time members. The legal framework will be analysed and evaluated in accordance with the objectives set out by the Preamble of the Indian Constitution and in light of the Directive Principles of State Policy.
- China and Norway agreed to set up green transition talks every two years. The talks will aim to foster connections and cooperation to reduce greenhouse gas emissions, protect and restore biodiversity, and create new green industries and jobs.

- The Biden Administration on Monday, September 9, said it had finalized regulations to help ensure the 175 million Americans with private health insurance have access to affordable mental health services. The Mental Health Parity and Addiction Equity Act, 2008 already requires insurers and corporate-backed health plans to provide access and payment structures for mental health care services on par with other medical services. The final rule, proposed last summer, is aimed at closing the gaps by requiring health insurers to evaluate which mental health providers' services are covered by their plans, how much those providers are paid, and how often they require or deny prior authorizations for coverage. Where needed, such requirements may push health plans to add mental health providers to networks, according to a senior administration official. Most of the new regulation will take effect in 2026.
- South Korea convened an international summit on Monday seeking to establish a blueprint for action by setting a minimum level of guardrails for AI in the military and suggesting principles for responsible use, reflecting guidelines laid out by NATO and the U.S. Though any agreement is not expected to have binding enforcement powers, the summit also aims to ensure ongoing multistakeholder discussions in a field where technological developments are primarily driven by the private sector, while governments are the main decision-makers.
- Texas paralegals licensed under a proposed new program will be able to provide some legal services to low-income individuals, under rules preliminarily approved by the state's top court. The Texas Supreme Court said in an order on Tuesday that allowing licensed legal paraprofessionals to deliver limited legal services in areas including family law, estate planning, probate law, and consumer debt law will help close the "justice gap" and address unmet civil legal needs.
- Law firms are capitalizing on client uncertainty sparked by a flurry of new U.S. Supreme Court rulings that favoured opponents of federal agency powers, even as lawyers themselves differ on the decisions' immediate and long-term effects. Within hours of the rulings, major U.S. law firms began sending out client-focused emails and webinar invitations to discuss the cases and showcase their expertise, a marketing strategy that often follows major legal developments.


